Racial Restrictive Covenants

Neighborhood by neighborhood restrictions across King County

What's In Your Deed? The language of segregation still haunts Seattle. It lurks in the deeds of tens of thousands of homeowners living in neighborhoods outside of the Central Area and the International District. Look deep in the fine print. Many Queen Anne residents, for instance, have this clause in their deeds: *"No person or persons of Asiatic, African or Negro blood, lineage, or extraction shall be permitted to occupy a portion of said property."*

Racial deed restrictions became common after 1926 when the U.S. Supreme Court validated their use. The restrictions were an enforceable contract and an owner who violated them risked forfeiting the property. Many neighborhoods prohibited the sale or rental of property to Asian Americans and Jews as well as Blacks. In 1948, the court changed its mind, declaring that racial restrictions would no longer be enforced, but the decision did nothing to alter the other structures of segregation. It remained perfectly legal for realtors and property owners to discriminate on the basis of race. In 1968, Congress passed the Housing

Rights Act, finally outlawing discrimination on the basis of race or ethnicity in the sale or rental of housing. Since then it has been illegal to act on the race restrictions that are embedded in so many deeds in Seattle and other King County communities.

Below is part of our database of racial restrictive covenants. Combing through the files of the King County Recorder's Office and King County Archives, we have uncovered more than 500 deeds and covenants containing racial restrictions that apply to at least 20,000 properties in scores of neighborhoods in Seattle and nearby suburbs. This is just a sample of the restrictions that shaped the housing options for King County residents in the past and in subtler ways may still affect neighborhoods today.

Look at the list of neighborhoods. North of the ship canal most neighborhoods were restricted, as was Capitol Hill, Madison Park, Queen Anne, and Magnolia. We have found a few restrictive deeds in Beacon Hill and Rainier Valley, more in the lakeside neighborhoods from Madronna to Rainier Beach. Racial restrictions were still more common in the suburbs. People of color had little chance of finding housing except in the central neighborhoods of Seattle.

Look also at the language of restriction in these deeds. Some specify that neighborhoods are reserved for "Whites," while others enumerate the prohibited racial groups. And the wording is curious. In the terminology of the 1920s-1940s "Hebrews" meant Jews; "Ethiopians" meant African ancestry; "Malays" meant Filipinos. Most shocking is the **"Aryans only" restriction** imposed on a subdivision in Clyde Hill. That racial concept, favored by Adolph Hitler, was written into deeds as late as 1948.

Here is how to read the table below. When a neighborhood or developer subdivision is shaded pink, it means that the restriction was written in the subdivision plat or accompanying restrictive covenant and thus covered all properties in an area. Where we have found multiple copies of a restriction using identical language we have likewise assumed it covered all properties in an area. Click the links to see copies of the restriction documents. In the list below Seattle neighborhoods are followed by North King County suburbs, South King County, then Eastside suburbs. 
