Ask for help from your representative:

If a congressional office is asked to help get information from a federal agency, families must first complete a digital privacy release form so the agency will release your records. Without these forms, offices cannot get real-time updates from agencies, and delays can mean days without answers.

To be prepared, immigrant community members can proactively fill out a privacy release form with their congressional representative before an emergency arises. That way, if support is needed, your representative can act quickly on your behalf.

WORKSITE AUDITS & RAIDS

More than one million Washingtonians (1 in 6) are immigrants. Immigration enforcement actions at workplaces are a tactic used to detain a large group of individuals and are on the rise in our state. In this context, employers should take steps to prepare for encounters with ICE through I-9 audits and workplace immigration raids.

TOOLS FOR EMPLOYERS:

Work with the Washington Immigrant Solidarity Network to ensure that appropriate protocols for safely engaging with immigration enforcement authorities at your business are in place and support is available for your employees:

- Print and display WAISN's "Know Your Rights with Immigration" flyers in common areas such as the employee breakroom.
- Develop and train staff on protocols (see reverse side of this flyer) for engaging with immigration officials if they appear at your business or attempt to contact your employees while on the job.
- Designate which areas of your business are closed to the public with clearly marked signage. See the sample signage below.



- Host a Know-Your-Rights training for your employees with a trusted community organization.
- Maintain contact information for an immigration attorney who will be able to advise you in the event of immigration enforcement activities affecting your business.

WORKSITE AUDITS & RAIDS

ICE RAIDS

Train employees on the basics of interacting with immigration officials and their civil and constitutional rights:

- **DO NOT RUN.**
- **YOU HAVE THE RIGHT TO REMAIN SILENT & ASK TO SPEAK WITH AN ATTORNEY.**
- **YOU HAVE THE RIGHT TO NOT CONSENT TO ENTRY OR SEARCHES BY ICE WITHOUT A JUDICIAL WARRANT.** Train your employees to identify judicial warrants (as opposed to administrative warrants) using WAISN's "Know Your Rights with Immigration" flyer. If ICE presents a valid judicial warrant, employees should not attempt to interfere with their operation.
- **DOCUMENT THE ACTIVITY.** While ICE agents are likely to protest being photographed or filmed, your employees have the right to film and take pictures while they conduct enforcement activities at your business.
- **DO NOT SIGN DOCUMENTS WITHOUT AN ATTORNEY PRESENT.**

I-9 AUDITS

- **DO NOT PANIC** or take any sudden action against your employees if you are notified that ICE will conduct an I-9 audit of your workplace.
- **CONTACT AN ATTORNEY.** You could have only a few days to produce documents for ICE. An attorney can help you determine your obligations so that you do not unnecessarily endanger your employees.
- **NOTIFY EMPLOYEES IMMEDIATELY.** Keep them updated on the status of the audit as it progresses. If your employees are unionized, reach out to their union.
- **YOU ARE NOT REQUIRED TO PRODUCE COPIES OF EMPLOYEES' IDENTITY DOCUMENTS** and you should not have them.

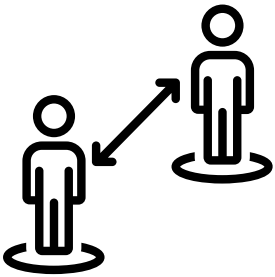
GUIDELINES FOR BYSTANDERS & OBSERVERS

In the U.S everyone has certain constitutional rights and protections regardless of their immigration status or who is president. You have the legal right to film the police and/or immigration officers if they are in a public place and if the filming does not impede the performance of their duties.

DOCUMENTING ICE ACTIVITY

STAY AT A SAFE DISTANCE

If you are asked to step back, take a step back while repeating: “I am exercising my right to record and document.”



IF THE OFFICERS GET TOO CLOSE

Say, “I am stepping back and have the right to record.” Speak in a calm, audible voice.



PROTECT VIDEO CONTENT ON YOUR PHONE

Make sure your phone is passcode protected. Not thumbprint or face recognition protected.



FOCUS YOUR RECORDING ON ICE OFFICERS

Record all the way through the incident. Narrate what you’re seeing. Say the date + time.



DO NOT GO LIVE ON SOCIAL MEDIA

for the privacy and safety of people being detained.

WHAT TO DOCUMENT



ICE OFFICER IDENTIFICATION

Name, badge, uniforms, vests



DATE, TIME, LOCATION

Location with specific address



LANGUAGE USED BY OFFICERS

Hate speech and identity speech (racist, sexist, homophobic), incorrect or unproven statements



ENFORCEMENT AGENCY VEHICLES

If they are marked or license plate states Police, Sheriff, Homeland Security (DHS), Immigration Enforcement (ICE). Unmarked but possible government vehicles.



VIOLENCE OR PHYSICAL FORCE

Pushing, shoving, grabbing, violence during arrests, damaging of property.



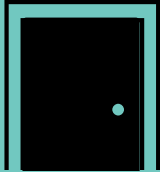

YOUR RIGHTS WITH IMMIGRATION

**IMMIGRATION & CUSTOMS ENFORCEMENT (ICE)
AND CUSTOMS & BORDER PROTECTION (CBP)**

YOU HAVE THE RIGHT NOT TO OPEN THE DOOR



COMMUNICATE THROUGH A WINDOW OR CLOSED DOOR.

ICE AND CBP AGENTS CAN ONLY ENTER YOUR HOME EITHER WITH YOUR CONSENT OR WITH A SEARCH WARRANT ISSUED BY A COURT AND SIGNED BY A JUDGE OR MAGISTRATE. (SEE BACK FOR EXAMPLE.)



YOU HAVE THE RIGHT TO REMAIN SILENT & NOT TO SIGN ANY DOCUMENT

YOU CAN SAY OUT LOUD THAT YOU WILL NOT ANSWER QUESTIONS OR SIGN A DOCUMENT WITHOUT AN ATTORNEY PRESENT.



YOU HAVE THE RIGHT NOT TO CONSENT TO A WARRANTLESS SEARCH

YOU HAVE THE RIGHT TO REFUSE THE AGENTS ENTRY TO YOUR HOME. AND YOU HAVE A RIGHT TO REFUSE WARRANTLESS SEARCHES OF YOUR BODY, YOUR CAR, OR YOUR HOME.



YOU HAVE THE RIGHT TO TAKE PHOTOS, VIDEOS, & WRITE DOWN DETAILS

YOU CAN INFORM THE AGENT THAT YOU ARE GOING TO USE YOUR RIGHT TO RECORD. (YOU MUST NOT INTERFERE WITH THE AGENTS' DUTIES OR THE SAFETY OF OTHERS.)



REPORT THE ACTIVITY TO THE WAISN DEPORTATION DEFENSE HOTLINE

WAISN HAS RAPID RESPONSE TEAMS THAT CAN BE ACTIVATED TO VERIFY AND DOCUMENT IMMIGRATION ACTIVITY AND OFFER SUPPORT TO THOSE AFFECTED.

NOTICE TO ALL LAW ENFORCEMENT & IMMIGRATION AGENTS

- This is a private business. You are not permitted to enter non-public areas of this business (including offices, break rooms, storage areas, and staff-only areas) without a valid JUDICIAL WARRANT signed by a judge or magistrate.
- An ICE administrative warrant (Form I-200 or I-205) does not authorize entry into private areas of this business.
- You may not question employees or search the premises without proper legal authority.
- All employees and visitors have the right to remain silent and the right to an attorney.



**IF YOU ATTEMPT TO ENTER THIS BUSINESS WITHOUT A
VALID JUDICIAL WARRANT, YOU WILL BE ASKED TO LEAVE.**



**IF YOU PRESENT A JUDICIAL WARRANT, PLEASE NOTIFY
MANAGEMENT AND LEGAL COUNSEL IMMEDIATELY BEFORE
PROCEEDING.**

IF YOU ENTER, YOU ARE TRESPASSING, AND WE WILL SEEK LEGAL RECOURSE.
